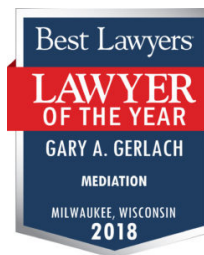

Judge Gerlach has had a State of Wisconsin Real Estate Broker's License for over 30 years. He has mediated and arbitrated numerous real estate and construction disputes.

Judge Gerlach has been named to the "Best Lawyers" for mediation and arbitration in 2018, the sixth time he has been listed in an ADR category. Judge Gerlach has previously been ranked among the top mediators in Milwaukee by Milwaukee Magazine, and among the best mediators in the state by the Wisconsin Law Reporter survey. He has authored several articles on the mediation process, as well as lectures on ADR for the Milwaukee and Wisconsin bar associations. He served as adjunct professor at the Marquette University School of Law Mediation Clinic, and was a director of the Wisconsin State Bar Association Alternative Dispute Resolution Section from 2002-2008.

Judge Gerlach has served as an external EEOC mediator, and has successfully mediated numerous EEOC charges and employment disputes to conclusion. He has also mediated age, race and gender discrimination cases.

Judge Gerlach combines the evaluative and facilitative mediation styles. He has completed several advanced mediation-training courses. He draws on his judicial experience, as well as his experience as a practicing attorney during the mediation process, instilling confidence among the parties in his observations and recommendations.

In addition to mediating and arbitrating cases, Judge Gerlach is available to serve as a judicial referee and private judge. He also provides analysis and feedback to attorneys and their clients involved in complex litigation regarding their arguments and legal interpretation.
